CUC can offer GSTC certification for both individual tourism enterprises as well as for groups of e.g. hotels or tour operators (group certification).

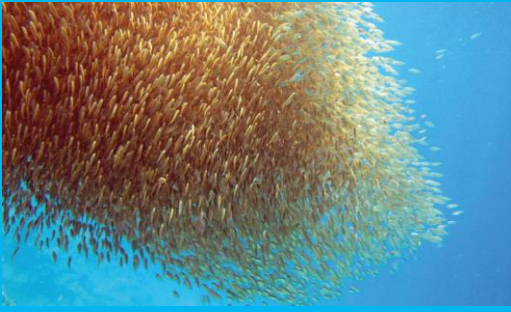
